

ISOC ELECTION CRITERIA 2022

Eligibility

a) In order to vote in these elections, a person must be:

i. A registered individual member of the Internet Society (ISOC)

ii. A registered member of ISOC Tanzania Chapter and not on probation as per the ISOC Tanzania consitution.

b) Persons who stand for any of the positions mentioned above, must meet the following:

General Criteria

No person shall be appointed into any of the offices if he/she is a person who:

(i) is under 18 years of age;

(ii) is an undischarged bankrupt;

(iii) No member of the Chapter shall be validly nominated for the position of Treasurer, Financial Secretary, Vice President and President if they are holding an executive position in any parallel entity/organization/association in the same Internet industry ecosystem /ICT, in Tanzania at the time of the nomination and election.

(iv) is not a natural person; or

(v) has been adjudged to have been of unsound mind

(vi) has been convicted with corruption related case or other misconduct

(vii) has been convicted with fraud related case or other misconduct

(viii) has been involved with mismanagement of funds related misconduct

A Nominee Shall:

a. be a registered individual member of the Internet Society (ISOC)

b. be nominated by one (1) ISOC member and be formally endorsed by at least one (1) ISOC member or be formally endorsed by at least two (2) ISOC members in case of self-nomination. A member can nominate or endorse not more than one candidate.

c. a member of ISOC Tanzania Chapter for at three (3) years in the case of President, Vice president and Secretary, and a member for at least two years (2) for all other positions;

d. Candidates for the posts of President and Vice president are expected to have at least five (5) years proven/verifiable professional experience in an area relevant to ISOC activities or ICT Industry.



e. All candidates are expected to present evidence of their involvement in some other volunteer roles.

f. Be available and committed to participate in ISOC Executive and general meetings (both local and global) and all other ISOC activities (face-to-face and online).

i.Candidate's detailed Curriculum Vitae describing applicant's professional experience, volunteer roles and qualifications.

iii. Name, Email address, Contact Phone numbers of Nominator and Seconders or two Seconders in case of self-nomination.
